

FROM THE PRESIDENT . . .

Speaking of bargaining, 45 years ago, February 28, 1968, the Association of Catholic Teachers won a consent election and became the sole and exclusive bargaining representative for lay teachers in the, then, 28 Archdiocesan high schools.

A great many of you cannot even remember a time when there wasn't a union or a negotiated contract. What you are all well aware of is the current contract predicament, a contract in force but still unsigned.

The major issue surrounding the blank signature lines is the Grievance Procedure. Simply stated, the School System wants to be able to determine which grievances can be grieved and which ones cannot.


It is unfortunate that over the past six months, there has been an ever-growing pile of grievances, filed, for the most part, against the System and the Superintendent. Using the System's scenario, the Superintendent terminates a teacher. The teacher files a grievance citing unjust termination. The Superintendent then gets to determine whether or not that teacher can grieve the termination. I don't think so!!!

This time, next year, the Association and the System will be opening negotiations for a new Labor-Management Agreement. Based on all that the Foundation wants to do to grow the schools, all the hard work the 17 schools are doing raising money as well as recruiting and retaining students, coupled with the educational excellence of our schools and our teachers, an all-summer negotiations similar to our last one (remember 2011?), seems a really terrible way to run a school system.

In contrast, the use of the Early Bird format, so successful in our 2008 contract talks, would seem to be a totally win-win situation. ACT has already proposed the use of the Early Bird to the Archdiocese.

As always, the Association will keep you updated on all of the above.





Charlie Blaszczyk–Requiescat in Pace!

Charlie Blaszczyk taught science at Bishop McDevitt High School for 49 years. He further served the school as an administrator and as a moderator of sundry activities. I had the privilege of traveling the McDevitt road with him for 39 of his 49 years. Charlie was already an established pro at McDevitt when I came aboard in the halcyon times of 1972. Charlie was always a professional colleague of mine, but it was really over the final 20 years that a kind of friendship emerged.

One of the iconic characteristics of Charlie's teaching style was his "trash can" conferences with his students. He would call the kids out one by one into the hallway. He would set up a trash can with his academic material on top, him on one side, and the student on the other. What would happen next was pure Charlie: an unvarnished assessment of the student's progress



in his class—emphasis on the word "unvarnished." Symbolically, the student had an interesting choice: improve or face the horrors of the trash can. I have taught side by side with many remarkable professionals in my own career at McDevitt; I have never seen anyone else on staff use the trash can in such an elegant manner as Charlie did.

Charlie could certainly have an "edge" in class. The edge usually came from exhorting his students to pursue excellence—something he wanted out of every student who sat in front of him. He would settle for nothing less and would have no problem in telling you if he thought that you were falling short.

In later years, life dealt Charlie a very difficult hand. After 25 years of marriage, he suddenly lost his beloved Rosemary, whom he had met at McDevitt. Life would never be the same for him, and those of us who were around Charlie could see the change in him.

Dealing with the loss of his wife and also coping with his own deteriorating health, I never heard Charlie curse the darkness. Very much like the Biblical Job, he seemed to shoulder an everheavier burden and soldier on. As a friend, it became difficult for me to watch his health deteriorate. As a colleague, it was brutally difficult to watch a man who had been so brilliant in science for so long and a man who had given so much to his school for so long begin to slip-slide away.

After he retired from McDevitt, I would get the occasional phone call from him. After the customary exchange of pleasantries, I always got the same question: "How's McDevitt?" In his final days, on the couple of times I visited him while he was in hospice, I always got "How's McDevitt?" He was most appreciative of anyone at McDevitt who extended to him the most minimal of courtesies.

Charlie Blaszczyk never left Bishop McDevitt High School. He taught science to thousands of high school kids and strived to instill in each one of them a passion for what was his own life's work. The over seven thousand Facebook hits on the McDevitt web page bear testimony to the impact that Charlie had on so many over the years. Good luck in trying to find a negative comment among those seven thousand messages. As long as McDevitt stands, Charlie will be among us.



R. I. P. Butch

It never occurred to me, when I first met Anthony "Butch" Capuano, that I would know this man for the next fifty-two years of my life. I was a junior at Bishop Neumann High School during the academic year 1959-1960 when Butch took over our Algebra II class at mid-year. The previous Teacher left the school; it wouldn't surprise me if the "cool" guys and their wild antics had something to do with his departure. Me? All I wanted to do was to learn Algebra, and for that first semester even the term "quadratic equation" scared me. It was too zany in that class to learn. To my delight, Butch came in and scared the daylights out of the in-crowd. Believe me, these boys were too intimidated by his menacing appearance, booming voice and don't-mess-with-me attitude to utter a syllable without his stern permission. Now, I loved it that I could learn Algebra.



Soon after I joined him as a colleague at Neumann in September 1965. We younger teachers became very aware of the kids' fear of deviating from his imposed vision of what constituted proper classroom decorum. At the beginning of each school year, the students would be spreading the word among one another about how Mr. Capuano "ripped a phone book" in front of their eyes. The kids definitely got the message.

Many of my fellow faculty who worked with him during his teaching years are now retired. I am sure that they, like me, have their own personal thoughts about Butch. I greatly respect their opinions and thoughts about him, whatever they may be. We could probably sit around for hours entertaining ourselves with Butch stories. I always felt that "Cap", straight up, either liked you or he didn't like you—and you didn't know why in either case. He just never sugarcoated anything. During the early 1980's, he refused to speak to me for about three months (until this day I don't know why). Then one day he declared that our little feud (what feud, I kept asking myself?) was over.

Butch's love of teaching was matched by his love of cooking. After our faculty Christmas parties, he'd invite some of us to his house on South 18th Street for more food, beverages, and fun. The food he had prepared was to die for. His love of the Christmas holidays was intertwined with his love of cooking. He and one of our priest faculty, Fr. Vincent Van de Weyer, would spend days preparing food for family and friends leading up to the holidays.

To this day, Butch's former students whom I bump into—many of them grandparents at this point—enthusiastically describe many and varied tales depicting their classroom experiences with him. But the common themes that permeate all these stories are the detailed preparedness with which he infused all of his teaching, and the extra one-on-one time he always gladly gave to students who were lost in the mathematical weeds.

Butch, you were a great man, a great teacher.

Until we meet again, sleep easy, big guy.
