

EARLY BIRD NEGOTIATIONS GET A THUMBS UP!

On October 2, 2013, the Association contacted the Secretary for Catholic Education with a proposal for an Early Bird Contract. In part, the Association said "Streamlining negotiations to reduce talks to a few significant contract areas and reach a contract settlement prior to the close of the 2013-2014 school year can only be a win-win for both the System and the Association. I certainly agree with you that this would be 'in the best interest of our kids, our families and our teachers.'"

On October 16, the Secretary for Catholic Education responded. "I am very much eager, like you, to begin the process so as to assure our families and our teachers long before they break for the summer that our schools are moving forward. It is my sense at this point that everyone is on board with the idea of an early bird and I am confident that we can get this done in an efficient and timely manner."

The process now begins: we will draw up the protocols, set opening and finishing dates, select our Teams and prepare our proposals.

ACT will be sending out surveys to our members asking for ideas for the new Labor-Management Agreement. The ACT Team will put our proposals together and ACT members will vote their approval at a membership meeting prior to the start of negotiations.

While all of us are very happy that there will be an Early Bird and that the scope of negotiations will be limited, the issues will be substantive. What is different is the attitude with which both Teams will be approaching the issues, certainly a welcome change from 2011.

The Association will keep the membership updated as we work through the process.


Lessons Taught and Learned



Everyman

John Quinn was a teacher. The lessons went far beyond the classrooms of Cardinal Dougherty or Archbishop Ryan, where he was on the original faculty, or Roman Catholic. They extended to his unexpected visits to the sickbeds and funerals of graduates and their families. Quiet, unassuming, consoling.

John Quinn was a coach. He was a six-time Catholic League Football Coach of the Year, who won both the North and South championships, while leading four different teams to the playoffs. Beyond the X's and O's, however, he coached his young charges that if losing a championship football game was the worst thing that ever happened to them, then they would have lived charmed lives.



John Quinn was a mentor. Many a student or youthful colleague looked up to John as a father figure. Jim "Gator" McCoy, a fellow teacher, referred to John as a "mentor, a facilitator for the young Ryan faculty back in the early '70's." Bob Fox, Ryan class of 1983, echoed the feelings of many when he wrote, "I thought of that man over the last thirty years as equal to my own father who was by far the greatest man I have ever known.'

John Quinn was a fighter. After a stint in the Army during the Korean War, John was a member of the football team at Notre Dame and also a champion of the Bengal Bouts Boxing Club. His biggest fight, however, was his eighteen-year battle with cancer. Eighteen rounds that he fought with the heart of a George Gipp, a Knute Rockne, a Rocky Marciano. You would never know when he was hurting, because he talked more about you than he talked about himself.

John Quinn was a character. If you attended a social event with him, it was not unusual to look over at his name tag and find that you were standing next to "Cary Grant." John Quinn was a lady's man. John Quinn was a man's man. John Quinn was Everyman.

John once published a book called, *Things I Wish I Had Said*. It was a book of quotations, so it's only appropriate that we finish with a quote. This one was offered by Rus Slawter, a former Ryan football player, which he attributed to Leonardo DaVinci: "As a well spent day brings happy sleep, so life well used brings happy death."

FLEXIBLE SPENDING ACCOUNT IMPORTANT ENROLLMENT INFORMATION

If you elect to participate in the 2014 Flexible Spending Account Program, please be mindful of the following:

The **Health Care** Flexible Spending Account allows you to pay for qualified medical and health care costs for <u>you and your dependents (family members covered under your medical plan)</u>. Eligible expenses include deductibles, co-payments, prescription glasses, orthodontia, and certain overthe-counter medicines and supplies.

The **Dependent Care** Flexible Spending Account helps you pay for <u>child</u> <u>or elder care services</u> so you and your spouse (if applicable) can work. Eligible expenses include child or elder care center, nursery or pre-school, after-school care and in-home care (for children and adults).

If you want reimbursement for health care expenses for you and your family members, you must check that you elect to participate in the Health Care FSA. If you need reimbursement for child or elder care expenses, you must check that you elect to participate in the Dependent Care FSA.

Please be very careful. If you check the Dependent Care FSA box and actually wanted the Health Care FSA, you will lose whatever money you apply to the Dependent Care FSA. There will be no reimbursement for monies put into the wrong account.

Seniority Lists Posted

Article V, Section 1a states "On or before October 31 of each school year, the Secondary School System shall supply to the Association and shall post in the individual schools a complete listing of all teachers in the Secondary School System including those on approved leaves of absence arranged according to system seniority and school seniority."

"Teachers shall have until December 15 to call attention in writing to errors or file grievances with the local school administration concerning their positions on the seniority roster."
