# **ASSOCIATION PRESIDENT SET TO RETIRE**

After 25 years in the classroom as a Mathematics teacher and Department Head at Archbishop Ryan High School, and after another 23 years on the staff of the Association of Catholic Teachers, Local 1776, **Irene Tori** will be retiring from the Secondary School System as well as from the Association of Catholic Teachers.

Irene has been a member of the Association of Catholic Teachers for 48 years, joining in 1977 when she began her teaching career at Archbishop Ryan High School for Boys. She was an active ACT member from the start, serving on every Negotiating Team since 1982 and representing ACT on numerous committees during her tenure.

Irene has held many positions on the ACT Executive Board. She was first elected to the ACT Executive Board in 1982 as a Member-At-Large. She held that position for two years before being elected Executive Secretary in 1984. She held that position until 2007. Next she was elected to Vice President, serving in that position through 2020. In October 2020, Irene was elected President and she would take over the office of President of the Association of Catholic Teachers in January, 2021. Irene's duties as President of the Association will come to a completion on December 31, 2024. Her position as ACT Staff will end on January 31, 2025.

## **FSA REMINDER**

If you were a participant in the 2024 FSA Program, please remember that all monies in your account should be exhausted by December 31, 2024. Any funds that remain in your account after December 31, 2024 will be lost. However, this does not mean that all your eligible expenses must be submitted by December 31, 2024. You have 90 days after the close of the calendar year in which to submit eligible expenses for 2024.

# **INSURANCE INFORMATION**

**Dental Plan:** As of January 1, 2025, you and each of your family members have \$1,000 in dental benefits to use for covered services in calendar year 2025. A list of your dental benefits is listed on the ACT Website at <a href="www.act1776.com">www.act1776.com</a>.

**Medical Plan:** Independence Blue Cross mailed out new identification cards to all its members. Please make sure when you visit your doctor or lab, you take a copy of your new card with you since your identification number has changed.

**Reminder:** Deductbles for Personal Choice PPO and Keystone HMO will reset on January 1, 2025. Therefore as of January, you will need to meet your annual \$100 individual deductible and/or \$200 family deductible for calendar year 2025. You may begin receiving bills for services, informing you that there is a deductible to be met prior to the insurance company making any payment.

These services include the following: Outpatient laboratory and pathology, home health care and/or hospice, skilled nursing, chemothereapy, radiation, dialysis, outpatient Private Duty Nursing, and physician/surgeon charges that require a deductible. (Please note that the deductible for the Personal Choice High Deductible Plan was reset on November 1, 2024.)

**Voluntary Vision Plan:** Open enrollment for the Voluntary Vision Plan has come to an end. **If you signed up for vision benefits, your plan will go into effect on January 1, 2025.** All members on the plan will receive a new identification card. For members who are currently on the plan and who will be remaining on the plan, <u>please make sure you give your provider your new identification number.</u> If you are currently on the plan and did not use the plan this calendar year, try and do so before your benefits expire on Decemer 31<sup>st</sup>.
